1. **NO GUEST FORMS WILL BE ACCEPTED AFTER 3 PM ON September 15. PLEASE SUBMIT EARLY.**
2. Attach a clear copy of the guest's valid driver's license or another government issued photo identification that shows the guest's birthdate. Current high school students may submit a copy of their school issued ID.
3. Each Viper attending the dance can bring ONE GUEST
4. No guests will be admitted to the dance without a Lake Buena Vista student; Student **AND** guests must bring a valid ID to the dance. **ALL (LBV STUDENT AND THEIR GUEST MUST CHECK IN FOR HOMECOMING TOGETHER)**
5. **Lake Buena Vista students and their guest must arrive at the venue before 8:00 p.m. at the latest with proper identification and their tickets. No students will be allowed admittance without a ticket and a form of photo identification.**
6. Guest tickets will not be sold until this form is approved by administration. **Allow at least 48 hours for approval.**
7. If you are planning on bringing an OCPS student from outside of Lake Buena Vista, both you and your guest must sign a copy of the OCPS code of conduct. A blank version of the form is available in Student Services or the front desk.
8. Guests will also need a print out from their school's Media Center showing that they have no fines. A student can not attend prom if they have fines.
9. **Guest tickets cannot be purchased online using TeachTix. Guest Tickets must be purchased in person with cash after the date waiver has been approved. Tickets will cost sixty dollars.**
